Presidential Message

The Board has recently received several complaints regarding neuropathy treatment programs. The programs apparently use various treatment modalities and equipment the patient takes home for use in treating their neuropathy. While treating neuropathy is within the scope of practice some of the programs we have received complaints on have questionable methods. There are statements that the program is ninety-eight (98) percent (%) effective.

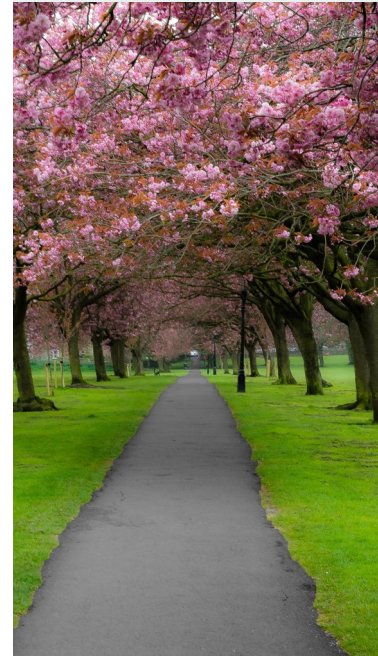
I would like to caution anyone who may be offering these types of treatment programs make sure that you can back any claims of the treatment effectiveness. The Board had a large case several years ago involving many senior citizens who were receiving treatment for neuropathy using questionable and unproven methods. The case ultimately ended with the Dr. surrendering his license. All of the cases we have looked into involve treatment costs in excess of 8 to 10 thousand dollars. The board looks at these very seriously and if you are offering these types of programs just make sure that the treatment is reasonable and clearly stated what it does and does not do.

2024-25 Renewal Reminder

If you have already obtained your required chiropractic continuing education hours for the August renewal, please forward a copy of the approved hours now. The hours certificate needs to have the Alabama approval number written on it. The renewal process is much smoother if you don't wait until September to obtain your hours and submit them to the Board. (18 hours are required for your renewal each year with part of those in Alabama Law).

You do not have to wait until you're ready to renew in mid August or September. The board staff will log your information into our system and you will be ready when renewal opens in August. 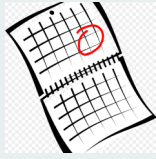
