The hours certificate needs to have the Alabama approval number written on it. (18 hours are required for your renewal each year with part of those in Alabama Law).

more days of testing and the ability to retake any deficiencies in a timelier manner. The parts I -III and PT exams will be offered at dedicated testing centers as well as on the college campuses. I personally attended the part IV test design committee meeting, and I like the design of the new test better than the current test and feel its design is more reflective of real practice decision making.

The Board staff is currently processing license and clinic permit renewals and dealing with the issues it usually entails. I recommend you login and start the renewal process as soon as possible to give you time to address any issues that may occur with deficient items such as your business license or missing CE that may need to be addressed. We have a lot of licensees that wait until the last week of September and try to beat the deadline to avoid late fees and this creates a tremendous bottle neck in the processing of your renewal.

I hope you have a speedy renewal and a great upcoming year in Chiropractic.

# **Do I qualify for a Retired License??**

- 1. Am I no longer in active practice? Note: In Alabama if a doctor practices one or more hours per year in <u>any</u> state he does not meet the guidelines for a retired license.
- 2. Do I want to place my license into a voluntarily retired status and relinquish all rights to actively practice chiropractic in the state of Alabama? Note: I understand this means I cannot do any fill-in work and I can not practice in another state.
- 3. I understand that I must submit the voluntary retirement affidavit and pay the annual renewal fee for Retired status.
- 4. In the event I decide to apply for return to active licensure status, I understand that I must comply with all renewal requirements in effect at the time.
- 5. I understand that if my license has been in voluntarily retired status for more than five (5) years and I apply for reinstatement to active status, in addition to all the requirements, I may be required to complete and pass Board approved refresher educational courses.

# **Renewing to Retired**

- Voluntary Retirement Affidavit on file or submit one prior to renewal
- \$162.50 Renewal Fee paid by September 30
- = A renewed current Retired License effective October 1, 2024
