

# ELECTION CHANGES STARTING IN AUGUST 2025

With the passage of HB84 the Board election process will slightly change. The Board will <a href="mailto:email

The Board will include what is required for a doctor to qualify to run as a Board Member and the deadline to qualify. Candidates qualify by submitting their name to the Executive Director of the board during the qualifying period. The Board will meet to qualify candidates and the ballots will be <a href="mailed">emailed</a> to each doctor by the independent agency. The results of the election shall be certified by the independent agency. You will need to watch for the <a href="mailed">emailed</a> ballot for your district and will need to check your spam to be sure you do not miss the <a href="mailed">emailed</a> ballot. The Board will notify you the email address the ballot will be sent from and the date the email will be sent.

The candidate with a simple majority of the votes cast in District 2 and 3 shall be elected to the board position for that congressional district. In the event no candidate in District 2 and 3 receives a majority of the votes, the independent agency shall hold a run-off election.

Dr. Ellis graduated from Life University and had dedicated over thirty years to chiropractic care in North Alabama.

Dr. Trilisa Ellen O'Quinn of Abbeville, Alabama passed away at home Tuesday morning, March 4, 2025.

Massage therapy led her to work for a chiropractor in Philadelphia. It was there that she decided to attend Life University. At Life University, she found joy in bringing chiropractic care to areas that needed it during week-long volunteer programs in Mexico and Jamaica. While at Life University, she received a Master's in Positive Psychology in 2016. Trilisa received her Doctor of Chiropractic in June 2020 from Life University. She was recognized on the President's List in June 2020. After graduation she worked briefly in Philadelphia but with Covid restrictions returned to Alabama and started Reconnect at the Lake.

#### HOW WILL NRII CHANGES EFFECT YOU AS A DC DOING DOT PHYSICALS AND IM-PROVE HIGHWAY SAFETY?

NRII improves the quality of driver medical certification information by replacing paper records with electronic records. FMCSA will now electronically transmit medical certification information from the National Registry to the SDLA. NRII also provides roadside inspectors and law enforcement officers with the most current medical certification information for these drivers. In addition, it eliminates the possibility of uncertified medical examiners issuing a Medical Examiner's Certificate, Form MCSA-5876, to CLP applicants and CDL holders as only certified medical examiners can report results of physical qualification examinations through the National Registry. As a result, NRII ensures drivers are medically certified to operate in interstate commerce, improving highway safety.
