Summary of Board Action Taken on July 10, 2020: On July 10, 2020, and pursuant to Governor Ivey's March 2020 proclamations, the Alabama State Board of Chiropractic Examiners held a specially called meeting needed to respond to COVID-19 by adopting the following emergency rule deemed necessary for the public's health, safety and welfare, which provides the Board the authority to revise continuing education requirements set forth at Administrative Code Sections 190-X-2-.11 during a Governor declared state of emergency. This emergency rule was adopted at this July 10, 2020 specially called Board meeting that convened at 2:00PM and adjourned at 2:26PM and is available for review below: EMERGENCY RULE: 190-X-2-.11-01ER Authority Waiving Live Classroom Event.
