Student Loan News

Per the Washington (AP) -

“A coalition of nursing and other health care organizations are angry over a Trump administration plan that could limit access to student loans in some cases.

Students pursuing graduate degrees in nursing physical therapy, public health and some other fields would face tighter federal student loan limits under the plan because it doesn't consider them professional programs.

The revamp is part of Trump's “Big Beautiful Bill” passed by Congress.

While graduate students could previously borrow loans up to the cost of their degree, the new rule would set caps depending on whether the degree is considered a graduate or professional program.

The Education Department is defining the following fields as professional programs: pharmacy, dentistry, veterinary medicine, **chiropractic**, law, medicine, optometry, osteopathic medicine, podiatry and theology.

Left out are nursing, physical therapy, dental hygiene, occupational therapy and social work as well as fields outside of health care such as architecture, education and accounting.

While the plan is still being finalized, the new student loan caps would take effect next July.

Act 2025-455

Per recent changes to Code of Alabama 22-8-4 the age of a minor to give consent has been raised from age 14 to age 16 (or older) to give consent for any legally authorized medical, dental or mental health services for himself or herself and the consent of no other individual shall be necessary.

(b) Notwithstanding any provision of law to the contrary, an individual who is 18 years of age or older may give effective consent to participate in any clinical trial, and the consent of no other individual shall be necessary.

(c) For the purposes of this section, a minor who is the parent of a child as provided in Section 22-8-5 or is pregnant may consent to any legally authorized medical, dental, or mental health services for his or her own child, and the consent of no other individual shall be necessary.

Section 3. This act shall become effective on October 1, 2025.

Quick Reminders

- The license and permit renewal period ended December 31 and if you failed to renew either of these you should not be practicing or operating a clinic at this time. Please contact the board office avoid any additional violations you may incur for practicing without a license.
- We would also like to remind everyone that if you move or change your practice location you have fifteen (15) days to notify the Board. Failure to notify the board is a violation of the rules.
- If you are using any prepay treatment plans please be sure to read and follow the board rules regarding trust accounting procedures. Board rule 190-X-4-.07 addresses prepayment procedures and refund processes if you are using these type of prepay programs.

190-X-2-.11 Renewal Of License proposed changes explained.

At the October 2025 meeting changes were proposed to the Renewal of License Process.

In regard to the renewal process that begins August 2026: annually shall mean October 1–September 30 of each year.

In regard to the requirement to obtain hours in Alabama Chiropractic Practice Act and Board rules: If adopted a licensee will obtain two (2) hours for renewal period.

The two (2) hours are included in the minimum of 18 hours and must be obtained in person by licensees who practice in Alabama.

This part remains the same: “Any individual who is initially licensed as a chiropractor in this state after October 1, 2011 shall complete as part of the continuing education requirement four (4) hours of continuing education in Board approved courses on chiropractic regulation and compliance with the Alabama Chiropractic Practice Act and Board Rules as a condition of renewal for the year following their initial licensure.”

Any individual who is initially licensed as a chiropractor in this state after October 1, 2025 shall attend one Board meeting during the first calendar year in which the individual practices in Alabama as a condition of renewal. Attendance may satisfy two (2) hours of required courses on chiropractic regulation and compliance with the Alabama Chiropractic Practice Act and Board Rules.

Inactive licensees may satisfy the requirement set forth above by distance based continuing education in addition to the distance-based education allowed in paragraph(3).

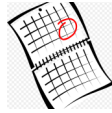
